III. REPORTS

A. Overview of 2018

Terry Bricco reviewed the 2018 year with the owners and answered questions. The rentals both from TPI and RCI were discussed and the owners thanked the board for all their hard work. Another topic was using the TPI exchange. Some of the owners would like training on the exchange. Terry said that could be arranged. B. Financial Status of the Resort

Terry Bricco reported on the financials ending December 31, 2018. There was a loss this year of (\$24,000). The resort received \$\$36,000 of rental income from unoccupied inventory. \$7000 was in the budget which meant there was a positive variance of \$29,691 in the rental category. The overall loss in the financials was due to bad debt. Delinquencies were 33%.

C. Management Company

Trading Places Exchange services were discussed along with owners renting their weeks out.

IV. APPOINTMENT OF INSPECTORS OF ELECTION

The inspectors of the election were Preston Hunt and Carol Wright.

V. ELECTION OF BOARD OF DIRECTORS (TWO OPEN POSITIONS)

Incumbent William T. Lowe and owner LoRie Thomsen were introduced and had an opportunity to address those owners present. William Lowe was not at the meeting and, therefore, did not make a statement. Robert Foxley then asked three times if there were any nominations from the floor. Hearing none, the nominations were closed.

VI. GENERAL DISCUSSION/OPEN FORUM

To answer several questions at once. Nancy Scott gave a quick overview and timeline of when the resorts renovations would be completed.

William Lowe was re-elected to another two-year term. LoRie Thomsen was elected as the new board member.
